America's Rule of Law by Justice Stephen Breyer

Upon the announcement of his coming retirement, Justice Stephen Breyer spoke to what he found particularly meaningful about his job as a Supreme Court Justice. He shared some of the ideas that he often expressed to students during his years of teaching. Here are a few.

This is a complicated country; there are more than 330 million people. And my mother used to say, "It's every race. It's every religion." And she would emphasize, "And it's every point of view possible."

And it's a kind of miracle when you sit there and see all of those people in front of you — people that are so different in what they think. And yet they've decided to help solve their major differences under law.

[I say to students] "Go look at what happens in countries that don't do that." . . . I take this around at my job. [Holds up a copy of the Constitution.] People have come to accept this Constitution, and they've come to accept the importance of a rule of law.

Election June 7, 2022 Primary

What is new?

- This election all 'registered' voters will get a ballot mailed to them at their current address.
- Vote-centers are where you vote in person. There will no longer be local precinct voting locations.
- Hold your ballot, walk in to your Vote Center and vote in person. Recommend you do this rather than mailing your ballot back to the Registrar's office.

Marin Election Countdown:

- April 28th Voter Information Guides will be mailed to all Marin County 'registered' voters.
- May 9th Vote-by-Mail ballots are mailed out. As soon as you receive your ballot you can fill it out and mail it back. Recommendation: that you vote on Election Day and vote at your Vote Center in person.
- **June 7th** Polls are open 7am 8 pm. at the Election Office and Vote Centers.

Legislative Report

By Ruth Holly – MRWF Legislative reporter A force for the dark side?

California State Senator Richard Pan, the son of immigrants from Taiwan, completed his pediatric residency at Massachusetts General Hospital. He has worked as a UC Davis clinical professor and leader of their pediatric residency program. This accomplished physician and legislator does not trust us to make health decision for ourselves and our children. As chairman of the Senate Health Committee, he is using his talents to attack the IV Amendment guarantee of the "right of the people to be secure in their person" with vaccine laws. He also hopes to keep the residents of California safe by seeking limits on their right to "freedom of speech."

SB 1390 would protect individuals on social media from receiving information they dislike from algorithm driven sources. The irritated recipients can report the offense to the California State Attorney General. If the information is not consistent with current government approved narratives on vaccination or other issues and is deemed misinformation or disinformation, the social media company is notified and must correct the algorithm within 24 hours or face a fine of \$100,000 per incident. This would allow Democrat activists to stifle dissenting ideas using enslaved social media platforms.

Paved with good intentions?

AB 2847 would establish a one-year pilot program giving \$300 a week to unemployed individuals who are not citizens or permanent legal residents. This bill is consistent with the Democrat goals of wooing the undocumented, devaluing citizenship, and ignoring the interests of taxpayers.

AB 1599 sponsored by Republican Assemblyman Kevin Kiley to repeal most of Proposition 47 failed. Proposition 47 decreased the penalty for non-violent crimes and made theft of \$950 or less a misdemeanor.

AB 1597 which proposes increased penalties for multiple offenses also failed.

AB 1603 which decreases Proposition 47 theft amount to \$400 if approved by the voters of California has yet to be heard by the Public Safety Committee.

AB 1638 Assemblyman Kiley's bill to suspend the 51.1 cents/gallon California state gasoline tax for 6 months was defeated. The tax is indexed to the California Consumer Price Index and is scheduled for its annual increase in July.

SCR 5 Republican State Senator Melissa's Melendez was unsuccessful in ending Governor Newsom's covid-based State of Emergency.




