President's Report

What country is this? Elected officials are viciously fighting election audits while claiming election transparency. Racism is taught in schools and corporations to "fight" racism. Our president has told landlords they cannot charge their tenants rent, cancelling private contracts and ignoring our most basic and prized property rights, as he ignores that the Supreme Court has already ruled the program unconstitutional. In six months, we went from having our most secure border in decades to the least secure ever, increasing drug and sex trafficking to new highs. Illegals are coming over the border with COVID and are flown pro bono to towns across the country, but Americans cannot go to restaurants, attend universities, or keep their jobs if they are unvaccinated. Legislative Report

Your Marin County Schools

Ethnic Studies - The Slow March to Becoming a Public High School Graduation Requirement

California AB 2016 established a commission to develop a high school ethnic studies model curriculum. Despite public comments opposing the promotion of critical race theory, the California State Board of Education unanimously approved the ethnic studies model curriculum on 3/19/2021.

AB 101 would require public high schools to offer a one semester course in ethnic studies by the 2025-26 school year and would make the course a high school graduation requirement starting with the class of 2030. The ethnic studies class must be "(A) a course based on the model curriculum in ethnic studies developed by the commission, (B) an existing ethnic studies course, (C) an ethnic studies course taught as part of a course that has been approved as meeting the A–G requirements of the University of California and the California State University, or (D) a locally developed ethnic studies course approved by the governing board of the school district or the governing body of the charter school".

Your California Representatives: Assemblyman **Marc Levine** voted for this bill 5/27/21 and State Senator **Mike McGuire**, a member of the education committee, voted for the bill 7/14/21. The bill is currently in the senate appropriations committee. ¹

California School Curriculum Development

Do our public school parents and we, the taxpayers, know how it works? Legislative curriculum bills get passed and end up in use by your local School Boards:

State legislated curriculum models are reviewed and approved by the **California State Board of Education** (11-member governor appointed board which approves state textbooks and creates regulations based on state law)

 our elected California Superintendent of Public Instruction oversees education department staff (who also assist with curriculum development), relays

- information to county superintendents, distributes any associated funds, and monitors compliance
- our elected Marin County Superintendent of Schools (with the assistance of staff and oversight by our elected Marin County Board of Education) relays information to district superintendents, provides teacher training, distributes associated funds, and monitors compliance
- school district board members (who select district superintendents and hire school principals) approve local curriculum (and textbooks from the state approved list)
- school district superintendents and school principals inform teachers of curriculum changes, provide training and educational resources, and monitor compliance at the classroom level.

Ethnic Studies Curriculum in Marin County

"Mary Jane Burke, Marin County Superintendent of Schools, met with high school superintendents in September 2020 to discuss the possible future Ethnic Studies graduation requirement and to discuss measures to counter antisemitism. A team of teachers, a member of the Anti-Defamation League, and a community member were charged with developing course curriculum materials that address antisemitism. Material for African American, Asian American, Latinx/Chicano, and Native American studies was also developed with the input of the Asian American Alliance of Marin, the Canal Alliance, and the American Indian History Museum."

The Tamalpais Union High School District already offers a semester long ethnic studies course and the Novato Unified School District unanimously approved a semester long ethnic studies class 8/3/2021.² The Novato School Board meeting supporting documents plainly states the focus of this class. "The first unit in this course introduces students to Critical Race Theory and how this concept and framework will be used to assess and analyze historical and current events, systems, laws and policies."

Critical Race Theory

Critical race theory is a neo-Marxist, anti-white, racist ideology that promotes redistribution of resources on the basis of group "equity".

Christopher F. Rufo, a journalist and filmmaker, leads in the fight against this ideology. "Critical race theorists must be confronted with and forced to speak to the facts... Do they support mandatory curricula teaching that 'all white people play a part in perpetuating systemic racism'? Do they support public schools instructing white parents to become 'white traitors' and advocate for 'white abolition'?" ³




