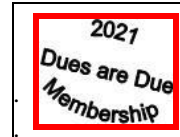

Legislative Report - California

Date: 2/11/2021 and 2/18/ 2021

Various

- **AR 18** – Assembly Resolution 18 – Resolved by the Assembly of the State of California, that the following Members of the United States Congress be permanently banned from being granted the privilege of access to the floor in the Chamber of the California State Assembly: From California: Ken Calvert (R-CA); Darrell Issa (R-CA); Devin Nunes (R-CA), Kevin McCarthy (R-CA), Doug LaMalfa (R-CA), Mike Garcia (R-CA), Jay Obernolte (R-CA), Status: *(Introduced) 2021-02-04.....Warms the heart, doesn't it?*

- **SB 273** – Infrastructure/ Water – Water quality: municipal wastewater agencies An act to add Chapter 11.5 (commencing with Section 13910) to division 7 of the Water Code. This bill grants additional authorities to municipal wastewater agencies to enter into agreements with entities responsible for stormwater management for the purpose of managing stormwater and dry weather runoff. In order to carry out the powers granted, and the purposes established, under this chapter, exercise any of the powers otherwise granted to it by law, including, but not limited to, enforcing compliance with local, state, and federal water quality requirements through the implementation of the municipal wastewater agency's industrial pretreatment programs and ensuring that the project or program is consistent with local watershed priorities, obligations, and circumstances. It also grants authority to levy taxes, fees, and charges consistent with the municipal wastewater agency's existing authority in order to fund projects undertaken pursuant to this chapter.

- **SB 300** – Crimes: Murder: Punishment – Under existing law, someone who is not the actual murderer but is found guilty of first-degree murder as a major participant in certain specified felonies aided ... in the commission of that felony shall be punished by death or imprisonment without the possibility of parole. This bill would repeal the provision requiring death or lifetime imprisonment for someone who is not the actual murderer but acted with reckless indifference. It

would also provide a procedure for currently incarcerated inmates previously convicted and awaiting execution or serving life sentences without the possibility for parole to petition the court to recall the sentence and resentencing that individual. *CAN YOU SAY, "Followers of Charles Manson"?*

Healthcare

- **AB-97** – Insulin Affordability – States the Legislatures' intent to enact legislation to make insulin more affordable for Californians. No further information is available.

- **SB-56** – Medi-Cal: Eligibility – Similar to AB-4, this bill would, subject to an appropriation by the Legislature, and effective July 1, 2022, extend eligibility for full-scope Medi-Cal benefits to individuals who are 65 years of age or older, and who are currently not eligible due to their immigration status. The bill would delete provisions delaying implementation until the director makes the determination described above. The bill would require the department to seek federal approvals to obtain federal financial participation to implement these requirements. Because counties are required to make Medi-Cal eligibility determinations and this bill would expand Medi-Cal eligibility, the bill would impose a state-mandated local program.

Education

- **AB 424** – Private Student Loan Collections Reform Act: collection actions – This bill would prohibit a private education lender or a private education loan collector from initiating a private education loan collection action unless the private education lender or private education loan collector possesses all of the specified documents.

Housing

- **AB 71** – Statewide homelessness solutions program – Increase taxes – This bill will attempt to solve homelessness by imposing higher taxes on people and corporations, higher corporate taxes, closing corporate tax loopholes, and repeal stepped-up basis of inherited assets. It also appears to have a retroactive element (section 23151 (2))

Elections

- **SB 29** – EIPCa strongly opposes SB 29 because it will mandate the automatic mailing of vote by mail ballots to ALL active registrants, requested or not, for all elections in 2021 even though that same mandate created a huge problem in the 2020 election. (Election Integrity Project-CA)

Supreme Court action on 2/22/2021 – Election 2020

Another Supreme disappointment: Headline–Supreme Court Dismisses Slew of 2020 Presidential Election Lawsuits *** One of the now-dismissed appeals, Republican Party of Pennsylvania v. Degraffenreid...dealt with the perceived overreach of the State supreme court when it unilaterally changed election rules without the consent of the State legislature. *** On Feb. 22, Alito wrote in his dissent, joined by Gorsuch, that review should be granted because the case presents “an important and recurring constitutional question: whether the Elections or Electors Clauses of the United States Constitution ... are violated when a state court holds that a state constitutional provision overrides a state statute governing the manner in which a federal election is to be conducted. That question has divided the lower courts, and our review at this time would be greatly beneficial.” In his dissent, Thomas expressed frustration, writing that the court “failed to settle this dispute before the election, and thus provide clear rules. Now we again fail to provide clear rules for future elections.” **TET** *The fact that three Justices dissented is compelling evidence that the majority denied certiorari for political rather than legal reasons.*

This is worse than sad.

It’s corrosive of our country’s founding social contract.

Six justices have bartered slipshod defense of the U.S. Constitution for the supposed (but illusory) ‘repose’ of Election 2020.
