Topic: Warriors Helping Warriors



‘Warriors Helping Warriors’ is the guiding principle of the organization, Paws for Purple Hearts (PPH).

Have you ever seen a veteran in a wheelchair with that well behaved, attentive, but still calm, dog by his side? And have you wondered how that training happens.

Come and meet one of these special dogs!

The concept of Service Dog was created by Dr. Bonita Bergin to assist people with mobility limitations in 1975. At that time, she founded [Canine Companions for Independence](#) (CCI), the first nonprofit to train and place Service Dogs. After leaving CCI, Dr. Bergin started Paws for Purple Hearts. PPH is the first program of its kind to offer [Canine Assisted Warrior Therapy](#)® to help Veterans and active-duty military personnel with PTS, TBI and mobility issues.

The dogs provide both physical and mental support and can be very helpful in mental health treatment. With the Bergin method our brave injured Warriors become involved in the training and preparation of service dogs for their comrades in need. The Warriors themselves actively train Service Dogs for their injured comrades.

President's Report

POW/MIA Table – The Missing Man Table

In May MRWF calls your attention to a small table that symbolizes the military personnel who are missing from American families and their designated Armed Forces.

Here is a description by our military of this ceremonial remembrance:

Our small white table is set in many mess halls as a symbol for and remembrance of service members fallen, missing, or held captive in the line of duty. It represents the frailty of one prisoner, alone against his oppressors.



We understand and appreciate the depth of sacrifice. It is just a little white table, but we use a small table to show one soldier's lonely battle against many. We cover it with a white cloth to honor a soldier's pure heart and purity of intention to respond to our nation's call to arms as he answers his country's call to duty. We place a lemon slice and grains of salt on a plate to show a captive soldier's bitter fate and the tears of families waiting for loved ones to return. The single rose in the vase signifies the blood they may have sacrificed to ensure the freedom of our beloved United States of America. The red ribbon on the vase represents the red ribbons worn on the lapels of thousands who demand proper accounting of

those who are missing. The glass is inverted; they cannot toast us at this time. The candle is reminiscent of the light of hope. We push an empty chair to the table for the missing soldiers who are not here. The American flag reminds us that many of them will never return and have paid the Supreme Sacrifice to ensure our freedom.

MRWF will set a 'Missing Man' table at our May 22nd luncheon in preparation for Memorial Day.

Memorial Day

The Civil War, which ended in the spring of 1865, claimed more lives than any conflict in U.S. history and required the establishment of the country's first national cemeteries. By the late 1860s, Americans in various towns and cities had begun holding springtime tributes to these countless fallen soldiers, decorating their graves with flowers and reciting prayers.

On May 5, 1868, General John A. Logan, leader of an organization for Northern Civil War veterans, called for a nationwide day of remembrance proclaiming, "The 30th of May, 1868, is designated for the purpose of strewing with flowers, or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village and hamlet churchyard in the land." The date for Decoration Day (as he called it) was chosen because it wasn't the anniversary of any particular battle.

Gradually, Decoration Day came to be known as Memorial Day, and while it originally honored only those lost while fighting in the Civil War, the day evolved to commemorate American military personnel who died in all wars. Formal rituals: on the last Monday in May the American flag is to be hung at half-staff until noon, then raised to the top of the staff; all Americans are encouraged to pause for a National Moment of Remembrance at 3 p.m. local time.

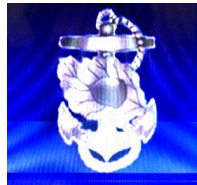

Legislative Report

Who benefits from the California Housing Mandate? Our state and local governments subject private developers to burdensome regulations and planning commission delays that increase the cost of building housing and then complain about the housing affordability crisis. State legislators have waved many of these requirements for housing non-profits supported by tax dollars. Taxpayers are forced to finance the construction of high-density, low-income housing in their neighborhoods and then continue to subsidize the non-profits and residents who do not pay property taxes. More affluent areas are targeted by the state for the highest density low-income housing. The housing non-profits cannot legally donate directly to political campaigns, but their founders and employees can donate money and time as individuals. **AB 1893** (Wicks) modifies the “builder’s remedy” for localities that do not have a state-approved housing element by adding some modest building restrictions.

Huntington Beach, a charter city, is being sued by State Attorney General Bonta for passing a voter ID law. Fair elections will not be tolerated! The state is also suing Huntington Beach for not complying with the state housing mandate. If every city followed their example, maybe we could loosen the state’s chokehold! The Chino Valley Unified School District should be commended for passing a policy requiring parents to be notified in writing if their child asked to be called by the opposite gender, changed his or her name or his or her pronouns, or asked to use the opposite gender’s bathroom. Of course, State Attorney General Bonta sued the school district, and a judge blocked the policy stating that individuals who identify as transgender are a “protected” class according to state and federal law. Sadly, these children are not being protected from the gender ideology that threatens their mental health and may lead to their disfigurement and sterilization.

SB 1011 (Jones) limits homeless encampments within 500 feet of a school, major transit stop, or open space. It would also restrict camping on public sidewalks and streets if shelter is available. Vagrants would be given 72 hours to move their belongings and be informed of available shelter beds and mental health services. Only the lone Republican on the Senate Public Safety Committee voted for this measure during its first hearing. Democrats voted down a similar bill in 2023. Of note, the bill was based on a San Diego ordinance that succeeded in moving encampments to the side of freeways and the banks of the San Diego River.

Tired of springing forward and falling back? Support **AB 1776** (Ta) and **SB 1413** (Niello) and return California to year-round standard time.

U.S. Congress seat vacated by Kevin McCarthy – What happens now? Watch the May 21st election.

There is a special election on May 21, 2024 for the Central Valley California seat in the U.S. Congress vacated by Kevin McCarthy.

Governor Gavin Newsom issued a proclamation declaring a special election for the 20th Congressional District.

If no candidate wins a majority of the vote in the Bakersfield-area district, the top two candidates, regardless of party, will move on to a general election, scheduled for **May 21st**. The winner will serve for the remainder of McCarthy’s House term.

Meanwhile, the election to win McCarthy’s seat for a full term in November will already be decided, with a primary set for **March 5th**. Several state and local GOP officials, including Assemblymember Vince Fong, Tulare County Sheriff Mike Boudreaux, are already vying for the seat.

California's Red Ink is Negatively Impacting Municipalities Large and Small

The State of California is hemorrhaging red ink with a massive budget shortfall. The non-partisan Legislative Analyst Office estimates the deficit at \$73 billion; Governor Gavin Newsom claims to be optimistic and pegs the shortfall at \$38 billion. A gap of \$30 billion is more than a *bit* of optimism.

If the deficit is closer to the Analyst Office's projections or any economic slowdown occurs, cities and county governments will bear the brunt. Newsom's budget proposal, which will be modified by the legislature, includes delays to programs in behavioral health, reductions in parks and open spaces, libraries, childcare, education, and transportation, all of which will directly impact local government.

There are "reversions," or cuts, of approximately \$1 billion in various housing programs this year and \$1.7 billion over the following years. Political hypocrisy should not shock anyone. We are undoubtedly in a housing crisis, and the State has mandated a specific number of affordable housing units for each city. Yet the "reversions" in housing aid result in a demand by the State of each city but pulls back needed financial assistance.

The State's fiscal shortfall negatively impacts municipalities large and small. I began my career in decision-making levels of Los Angeles city and county government and now reside in Rancho Mirage in the Coachella Valley.

Los Angeles is confronting what the *Los Angeles Times* termed a "budget mess." The city of nearly four million will have to freeze hiring, cut services, and raise fees. San Francisco is confronting a \$245 million shortfall this year and a \$555 million deficit next year. Mayor London Breed's budget director stated, "We're in a tough spot."

The Governor's proposed budget does not include any raids on local government. Yet the legislature will explore every option before the June 15 deadline. Cities must anticipate this challenge and be proactive.

Let's look at my hometown of Rancho Mirage (near Palm Springs), which has 18,000 residents. The Rancho Mirage City Council adopted a budget with an "assumption that the local economy will continue to thrive." Thrive? Maybe.

No doubt local budgets will get squeezed, but let's protect our priorities:

- 1) Los Angeles has three Council members who voted against raising salaries for the Los Angeles Police Department. Anything is possible with those self-described "super progressives." Yet budgets for police, fire, and emergency medical technicians should not be reduced. Public safety is the number one job for municipal governments.

2) Infrastructure is never sexy but always vital. The state deficit delayed an \$8 million grant to Palm Desert for flood retention basins from the State's Regional Early Action Planning (REAP) program. Delaying infrastructure programs recalls the old "pay me now or pay me later" television ad. Look for cities to mobilize and lobby their state representatives to protect critical funding to resolve problems today and minimize damage tomorrow.

3) The super-majority Democratic California legislature is never termed as pro-business. Yet local governments depend on revenue from the sales and bed tax/transit occupancy tax. Stubborn inflation and the work-at-home sea change have spiked office vacancies, and the ripple effect has been vacant storefronts and retail uses. Local governments should engage with their local business community to retain existing businesses while attracting and encouraging new ones.

Despite California's budget woes, special interests continue to push for more funding. Newsom's proposed budget allocates \$22,850 per student, yet California Now is pressing for an additional \$23 billion annually in education spending. Look for the potent teacher's union to flex its political muscles.

Newsom's proposed budget is misguided in two areas. . .
